18. Proposals

18.1. Changes of Reimbursement (see DC 2023 | Zonta District 28)

Since the current reimbursement guidelines date from 2017 the District Board saw a need to change these guidelines in order to take into account the developments of the last years. The reclining numbers of rules have led to a decrease in membership fees and the pandemic has proved that meetings can also be held efficiently online.

The following changes are proposed

- Printing and communication costs shall not be reimbursed anymore.

The proposed change: "Delete without replacement" is unanimously approved (64 YES – Votes)

- District payment for hotel accommodation

DBoard members are encouraged to share hotel rooms or use offers from sharing platforms that often are more economical. With the proposed change it is clarified how the costs for accommodation are being reimbursed.

The proposed change is unanimously approved / (64 YES – Votes)

- Travelling costs

The maximum amount reimbursed will be the train ticket, when purchased at the earliest time possible. Only for a train travel of more than 3 hours the first class fare shall be reimbursed.

Votes: 62 YES / 2 Abstentions

- Formal change regarding titles/subtitles in order to ease the reading of the guidelines.

The proposed change is unanimously approved / 64 YES – Votes)

18.2. Rules of Procedure (see DC 2023 | Zonta District 28)

18.2.1

The following change is proposed and discussed: For continuity and efficiency the bank account of District 28 shall be kept in Switzerland with Postfinance AG. 2
Board members shall be in charge as the main contacts and as Admin users in the bank relation. One of the two shall be a board member domiciled in Switzerland.

Proposal 1.

"The District Board has therefore analysed the possibilities to decouple the opening and closing of bank accounts from the change in District Treasurers. The current account for District 28 is held with Postfinance AG in Switzerland. Postfinance is not a regular bank but offers all the bank services that the District needs. It is state-owned and therefore safe and, as a consequence, it is lessregulated than regular banks. With the possibilities of e-Banking, which are offered by Postfinance AG, the country of residence of the Treasurer is irrelevant. This means that it is possible to keep the account in Switzerland and a Zontian from Italy or Germany can manage the accounts. The main contact for the account, the Postfinance liaison, will have to be a Swiss Board member. That Postfinance liaison s only obligation will be to grant rights of access to the elected Treasurer in charge and to pass on administration rights to her Swiss successor. "

Discussion/ questions / answers

 There are many Clubs in Area 02. Do they have to pay fees for payment transactions?

Treasurer D. Rutishauser: At the moment there are no fees between Switzerland, Germany, Italy.

Is it true that the treasurer must be Swiss?

No, the treasurer doesn't have to be Swiss since it is possible to organize the bank account online. Yet, one of the two signing persons should be Swiss.

Have you thought about opening an online bank account?

After extensive research, Postfinance Ltd is the only bank available for our organisation.

• Who is responsible to sign?

E-banking balances can be transferred and are not tied to Switzerland, whereby one of the responsible persons must be Swiss (e.g. Area Director). She has to sign and give her address, but does not have to hold the bank account.

Only the treasurer is responsible. Only she and the governor have access to the account, and if this is not done online, a collective signature is required.

What are the rules if there are more Swiss persons in the board?

In that case the board should come to an agreement.

• Can we have more information? Aren't there any other options?

There are no other options at the moment. Christine declares there are no negative changes, only reliefs. The only change is, that the bank needs a person that resides in Switzerland (Doris adds: or Liechtenstein).

Christine reads out the proposal.

Voting results:

The proposed change is unanimously approved (64 YES- Votes – 2/3 majority adhered to)

18.2.2 Changes Rules of Procedure

Proposal 2

- "Alignments with the International Standard Fees for Young Professionals should be adjusted in wording with ZI
- The age limit for young professionals has been set at age 30 in the District.
 Meanwhile, ZI has set an age limit of age 35 at the Convention in Hamburg."

18.3. Bylaws D28, Art. 2 Sent.1 (see DC 2023 | Zonta District 28)

The following amendment is proposed by Districtboard 28: Change of Art. 2, sentence 1 Bylaws D 28: Delete the number 3

Current:

 District 28 of Zonta International is an incorporated association and encompasses 6 countries with its clubs, divided up into 3 geographically delimited territories corresponding to areas.

Proposed Change:

 D28 of Zonta International is an incorporated association and encompasses 5 countries with its clubs, divided up into geographically delimited territories corresponding to areas.

Justification:

• The limit of 3 geographic territories narrows down possible new Area formations. Therefore, an opening is proposed.

18.4. Continuation YWPA/JMK (see DC 2023 | Zonta District 28

Proposal Continuation of prize money 2./ 3.place (YWPA/JMK) on District level

Application for extension of the prize money for YWPA and JMK (application for the next biennium)

 Each district/region will nominate a district/region applicant to submit to Zonta International; however, there will no longer be district- or region-level scholarships. If the district/region applicant meets the criteria for the scholarship, the individual will receive an international scholarship of US\$5,000 the same applies to YWPA Award.

18.5. STEM Award and Resolution to extend Women in STEM Scholarship for another biennium (see DC 2023 | Zonta District 28)

STEM AWARD District 28 moves to amend Zonta International Bylaws Article XIII Committees by changing the number of SECTION 15 to SECTION 16 and adding a new SECTION 15, with the following content: SECTION 15. Women in STEM Scholarship Committee. From submissions put forward by districts, this committee shall select and recommend to the Zonta International Board candidates for annual Zonta International Women in STEM Scholarships

 The Women in STEM Scholarship should be continued as a 4th pilot cycle on club, district, and international level for women in all STEM fields. An evaluation of the Scholarship shall be presented at the 2026 Convention.

Rationale

 The Women in STEM Scholarship, former was set up as a pilot program for three biennia because women are still largely underrepresented in technology and other STEM fields. To give women equal opportunities as men in technological developments, Zonta launched this pilot scholarship program in 2018. In 2020 the Scholarship was limited to international applications only and in 2022 it became a biennial district award and was expanded to STEM fields.

Goal: STEM is to be continued internationally at Zonta and shall become permanent.

If the Resolution is not adopted at the Convention, STEM should be continued as a pilot project for another two years.

Questions from the floor:

- STEM as a name is misleading. Could you put MINT behind it with a slash?
- Christine: Since a uniform appearance is desired, we would like to leave STEM as it is (without MINT)
- The German translation of STEM is MINT.
- Criteria for STEM are often not clear is this still being worked on?
- Annemarie: There is a pilot process at the district level which needs to be further developed. Christine assumes that criteria will also be discussed internationally.

Topic: Increase of the line item "Governor expenses"

In the proposed budget, the line item" Governor Expenses" is calculated with 3.400 Euro (Area meetings 2.400 Euro and Miscellaneous 1.000 Euro).

Based on the experience from previous biennia, we propose to increase this amount to 6.000 Euro.

Rationale:

Previous cost reports show that the actual costs were far above the 3.400 Euros proposed in the 2024-2026 budget (e.g. Biennium 2016-2018).

It is the task of the Governor, in addition to the Area Meetings, to visit the clubs on occasions like anniversaries and charter celebrations and specifically to foster communication with club members in the entire District.
